# **VIAC** Global Sustainable 80

The strategy VIAC Global Sustainable 80 implements a broadly diversified investment approach on a global scale that omits investments in gold as well as companies with significant involvement in controversial activities. Selection of securities in the funds is based on accepted sustainability criteria. The equity share is 80%, further 10% is invested in real estate. The remaining 10% of assets are held in the interest-bearing cash account (free of charge). Passive and cost-effective implementation is carried out with Swisscanto index funds. 

Trading takes place on a weekly basis. The interest is calculated following the actual/actual methodology and implemented on a monthly basis. The investment plan can be adjusted by the foundation band.
