VIAC Switzerland 60

The strategy VIAC Switzerland 60 implements a broadly diversified investment approach on a global scale that invests at least 75% of each asset class in Switzerland. The equity share is 60%, further 25% is invested in Swiss corporate bonds, 10% in real estate and 4% in gold. Passive and cost-effective implementation is carried out with Swisscanto index funds.





Trading takes place on a weekly basis. The interest is calculated following the actual/actual methodology and implemented on a monthly basis. The investment plan can be adjusted by the foundation board.
